Quotes for CCTV: Further quote from CSP for PTZ cameras £2332.68 includes all fittings, notices etc. Mr Chapman still recommends the original camera's quoted for at January meeting but would benefit from a visit to his showrooms to view all options. New Quote from WRS via Cllr Gray: 2 options Cameras sited on new pole adjacent play equipment £5367: Option 2 Cameras sited on roof port-a-cabin £ 3843.

Resolved: Due to the proposal for new changing facilities CCTV be put on hold until decision on above is made.

Both companies to be informed.

Proposed new Changing Facilities. Clerk reported no reply received from VHC re releasing funds for brick facilities. Cllr Gosling reported letter given to him today from Chairman VHC: There is agreement that a brick changing facility would be more viable and that this could be the 1st phase of the building of the hall and asked what financial contribution the Council would make. Their committee would then be looking at how much of this project could be built with current funds held. The letter has not been circulated to all Members. The Clerk was of the opinion that NLC would require a new planning application, Cllr Armitage stated that as plans for the hall had been passed building just a part should be OK. Cllr Gosling: whilst it had been agreed that the Council disengage itself from the VHC and agreed that all matters be in writing this could be made available for brick built unit, which was echoed by others.

Resolved: That the Council agree principle to a joint MEETING. TO SISCUSS

to discuss this in detail to be held on the rising of the March meeting.

Time Switch lights; TVES had been instructed to install new time switch as agreed at January meeting. No price agreed at that time quote £135.00 Accepted.

Also on quote was price for installing extra light to the existing post adjacent to porta-cabin (requested direct by Cllr Oldfield) to illuminate field for use as training for football teams £310.00. Man lift would be required and was not included in quote. Agreed that price for hire of lift be sought. Ongoing.

Gate Closure: No quote received; Cllr Porter was still of the opinion that a gate closure was not necessary

Allocate Precept to Budget Headings Min 29/2012

The Clerk had circulated figures for inclusion in budget for discussion purposes. Cllr Gosling brought to the meeting figures compiled by himself & Cllr Oldfield which were circulated at meeting. Clerk stated the Cash in Hand figure at £10,000 was below the figure estimated by £10,000, Cllr Gosling: This could be diverted to Community Fund.

Resolved; That the figure produced by the Chairman and Clir Oldfield be adopted.

Matters Relating to Lodge Moors Estate Min 30/2012

No matters referred: Clerk asked if LMRA was still in existence as the Council had received no information since the last Committee folded. Cllr Gosling informed Members that North Lincolnshire Homes was involved in helping to reform the association with local resident Ian McPherson as Chairman. Cllr Gosling: NLC were reviewing it's social services many adult centres earmarked for closure, Minster Centre being one of those, this could mean the building would be sold.

Clir Armitage: Any reply from NLC re the erection of "Deer Signs" on Neap House Road: Clerk stated two letters had been sent last year, neither replied to.

Brought on behalf of Clir Oldfield had been approached by resident of Farm Close for salt bin to be provided on the Close. Cllr Etchell informed the meeting that NLC would not provide further bins but they could be purchased by the Parish Council at a cost of £152 each. Alternative option to move bin from OVS/Empson's corner as Station/Neap House Road was on NLC gritting route. To March meeting for discussion financial involvement.

Cllr Craddock: Again dog fouling on playing field, banners erected do not appear to have improved this problem; Keadby village had now started locking their park at night which could mean that residents were now coming to Gunness to exercise dogs and proposed we should consider locking the field overnight. A person had expressed interest in taking responsibility for this, contact to confirm; decision at March meeting.

Cllr Etchell: Lights out on Keadby Bridge approach: report to NLC.

Cllr D. West: Large pothole on Station Road in vicinity of sub station danger to cyclists/ motor cyclists. report to NLC Highways.
